Nova Scotia Nature Trust secures pristine islands in promising focal area

Harbour and Prices Islands in Guysborough County add to growing conservation interest.

DECEMBER 4, 2023, HALIFAX, NS – Today, the Nova Scotia Nature Trust is pleased to announce a significant conservation gain in the province with the addition of 149.7 hectares (370 acres) of spectacular coastal wilderness just outside Canso, within the Mi'kmaw district of Eskikewa'kik.

Harbour and Prices Islands are, in fact, comprised of several small islands, but their significance is substantial, according to Bonnie Sutherland, Nature Trust Executive Director. "So far, there has been less coastal development here than in other parts of Nova Scotia, but very little is currently protected," explains Bonnie. "This win is an important step forward in an area that we hope sees more preservation soon while it remains relatively untouched," explains Bonnie.

Conservation interest within the Country Harbour Headlands Coastal Segment is growing, and Harbour and Prices Islands strengthen its network of protected places. The islands sit adjacent to the Canso Coastal Barrens Wilderness Area and are close to several other islands awaiting formal conservation designation. Their securement helps maintain the coastal area's integrity and increases connectivity for the associated wildlife.

The islands host a variety of habitats, including dramatic coastal barrens, softwood forest, and peatlands, as well as hundreds of breeding, migrating, and overwintering birds. Multiple species of gull nest there, and a Great Blue Heron rookery is also known to Harbour Island. Immediately adjacent to a globally significant Important Bird Area *(IBA)*, the surrounding coastal landscape supports an abundance of waterfowl, seabirds, and shorebirds, including Eiders, Mergansers, Purple Sandpipers and the Harlequin Duck, a species of special concern determined by the federal Species at Rick Act (SARA).

"There have been alarming declines of migratory birds since the 1980s, and facing this biodiversity crisis, the need to conserve important coastal islands is urgent says Bonnie. "Atlantic Canada and the eastern U.S. have suffered the greatest amount of coastal habitat

loss in recent years," she explains. "Saving intact islands like Harbour and Prices are critical."

News of this recent acquisition is not only good for nature but for people, too. Whitehead Harbour, surrounding the islands, is a known paddler's paradise, with many enjoying the area's unique recreational aspects and remote beauty, now protected forever.

The securement of Harbour and Prices Islands also supports the Nature Trust's recent Hope for the Coast conservation effort, whereby the organization has set a goal of acquiring an additional 5,000 acres of coastal property to help offset high rates of land fragmentation and development in the province. In addition to public funds raised, this land securement was made possible with the help of a generous donation by Nature's Way Canada through their participation in the 1% for the Planet program, the Government of Canada through the Natural Heritage Conservation Program, part of Canada's Nature Fund, and the Nova Scotia Crown Share Land Legacy Trust.

Hope for the Coast

The Nova Scotia Nature Trust's Hope for the Coast fundraising initiative is an urgent and targeted effort to save 5,000 acres of Nova Scotia's most ecologically significant coastal lands. Funds raised help to secure priority coastal lands through land donations, conservation agreements or purchases and ensure they are protected forever. Hope for the Coast contributes to the organization's Twice the Wild campaign, which aims to double the land it conserves by 2025.

Twice the Wild

Twice the Wild is an ambitious campaign to double the Nature Trust's protected areas - from 15,000 to 30,000 acres - by 2025. These achievements contribute directly to the federal government's commitment to save 30 percent of Canada's lands by 2030 and answer the global call for urgent action to address the biodiversity and climate change crises.
